## ABSTRACT SUBMISSION TERMS AND CONDITIONS – 9<sup>TH</sup> CENTRAL EUROPEAN CONGRESS OF LIFE SCIENCES EUROBIOTECH 2024

Please read this information carefully before submitting an abstract. By submitting an abstract you have agreed to Terms and Conditions.

- The conference registration system and abstract submission system are available on the
  website: <a href="https://eurobiotech.krakow.pl/">https://eurobiotech.krakow.pl/</a>. All abstracts must be submitted online
  through the abstract submission system. Abstracts sent by email will not be included in
  the abstract review process.
- 2. It is possible to upload maximum one (1) abstract by one delegate. Submission of the abstract is free of charge.
- 3. By submitting an abstract, the author agrees to give the Organizers permission on behalf of all co-authors to publish, reproduce, distribute, display, and store the abstract, together with the names of the author(s) after the acceptance of the abstract for the presentation.
- 4. The Organizers are not responsible for correcting typographical, spelling, or linguistic errors in the submitted abstract.
- 5. Authors declare that they have proprietary copyrights or necessary licenses to the submitted and then published materials and that the publication of the materials and their content is lawful and does not infringe the rights or goods of third parties.
- 6. If third parties raise justified claims against the authors resulting from the violation of the rights referred to in the paragraph 5, by publishing the materials provided, the authors providing the contested materials undertake to satisfy claims and pay royalties or damages that the Organizer would have to bear, together with all costs incurred for breaches.
- 7. The corresponding author should ensure that all appropriate co-authors are included in the abstract and that all authors have approved the submission.
- 8. At least one author must be available to present the abstract if selected for the poster or oral presentation.
- 9. All authors who are present at the conference must register and pay the conference fee to attend the conference as a delegate. If the presenting author is not registered as a conference participant, the abstract will be withdrawn.

- 10. The same e-mail address must be used tin the abstract submission and conference registration systems.
- 11. The authors will immediately notify the Conference Organising Office (via email <a href="mailto:eurobiotech@targi.krakow.pl">eurobiotech@targi.krakow.pl</a>) if they are unable to present an abstract or if the presenting author has changed.
- 12. The abstracts will be reviewed and accepted by the Scientific Committee. Submitted abstracts will be considered for poster or oral presentation by this Committee. The author must indicate the preferred form of presentation during the submission of the abstract. The abstract evaluation will be solely based on the content presented.
- 13. The Organising Committee may decide to allocate the submitted abstract to a topic other than the topic selected by the Author.
- 14. The Abstract Book will be available as a PDF file on the web page <a href="https://eurobiotech.krakow.pl/">https://eurobiotech.krakow.pl/</a>
- 15. If the author(s) have any commercial interests or associations that might pose a conflict of interest regarding this submission, they must be declared. If accepted for presentation, commercial interest or association must be declared on the title slide or on the slide immediately following the title slide (for oral presentation) or at the bottom of the poster (for poster presentations). All presentations should include funding and other acknowledgements where applicable.
- 16. The Organising Committee currently does not allow abstract submissions exclusively from Institutions in the Russian Federation and/or Belarus. However, collaborative research may be submitted and (if accepted) presented by co-authors from other countries.
- 17. Once a submission has been made, it is possible to make corrections to the content of the abstract or the information until the reviewer's assessment begins. The Committee is not authorised to make changes to a submission. Changes made after review are only possible if the abstract was return to correction by the reviewer. To correct your abstract, you must use the link received in the e-mail notification. In the event that errors were discovered in your abstract after review, you can indicate the correction in your presentation. If accepted, your abstract will be published as submitted.
