TERMS AND CONDITIONS OF 10TH CENTRAL EUROPEAN CONGRESS OF LIFE SCIENCES EUROBIOTECH 2026

§1. General provisions

- 1. The of 10th Central European Congress of Life Science EUROBIOTECH (referred to as Conference) takes place 2-3 July 2026 in International Exhibition and Convention Centre EXPO Krakow at 9 Galicyjska Street, 31-586 Krakow.
- 2. The Conference is organized by the Targi w Krakowie Ltd.
- 3. Registration for the Conference implies acceptance of the Terms and Conditions.
- 4. The official website of the Conference is the following: https://www.eurobiotech.krakow.pl/
- 5. Conditions of participation in the Conference are:
 - a. online registration,
 - b. making payment

§2. Registration

- 1. Registration for the Conference can only be made via online registration form on the website: https://www.eurobiotech.krakow.pl/
- 2. All registered participants must pay the required registration fees. Registration is considered valid only after the participant has made payment.
- 3. Please be aware that if the payment for participant who has accepted abstracts will not be completed by 31st of May 2026, the contribution will be cancelled and not inserted into the Book of Abstract.
- 4. All participants are obliged to fill in the payer's data carefully. The Organizer is not responsible for any consequences of providing false and/or incomplete information on the registration form.
- 5. After registration, participants will receive an automatically generated notification email to the email address provided in the registration form. If you did not receive a notification e-mail within an hour of submission of your registration, please check your spam folder/junk mail or contact the Conference Organizer to confirm your registration status.
- 6. After registering the participant will have an access to his profile in the system, to check the status of the registration.
- 7. Final confirmation of participation and all ordered services will be sent by email.

- 2. Participant's registration fee includes: Access to the system and the ability to submit an abstract, entrance to conference rooms and exhibition hall, Conference materials, participation in Welcome Reception, lunches, coffees and access to the official Conference mobile application (hereinafter: "Application"), enabling networking, agenda browsing, onsite navigation and other conference-related functionalities.
- 3. Registration fee does not cover the costs of accommodation.
- 4. The amount of the registration fee depends on the participant type, the fee category, and the date of payment.

§4. Payments, Invoices

- 1. The following types of payment are available:
 - a. payment by bank transfer, based on a pro forma invoice issued by the Conference Organizer. Information about the issuance of the pro forma invoice will be sent to the email address provided by the Participant in the registration form. All payments must include the following reference:: Participant's Name(s) + BIO 2026 and the number of pro forma invoice,
 - b. payment by online payment system (credit card or quick transfer),
 - c. credit/debit card payment on site (Organizers do not guarantee place or conference materials).
- 2. Bank expenses must be covered by the participant.
- 3. Participants whose participation in the Conference constitutes a vocational education service and is financed entirely from public funds are entitled to VAT exemption in accordance with art. 43 sec. 1 point 29 lit. c of the Goods and Services Tax Act of March 11, 2004. with later changes. The condition for taking advantage of the exemption is sending the completed and signed by the financing unit the form "Declaration for the purposes of VAT exemption of training courses" in electronic form (scan or photo) to the email address ksiegowosc@targi.krakow.pl before making the payment for the conference and making a transfer for participation in the Conference from the account of the institution financing the training. The file with the Statement is available for download in the Conference registration system and, at the participant's request, it can be sent electronically.
- 4. After the payment has been credited, an electronic VAT invoice will be sent to the client by email from the address notifications@syskonf.pl within 14 days of the payment being received in the bank account. Starting from April 2026, the invoice will be delivered in accordance with the new regulations.

- 5. The invoices referred to in points 4 of this paragraph will be issued on the basis of the data provided during registration (invoice data). The Conference Organizer inform that it does not correct the data entered incorrectly by the Participant on the issued VAT invoices.
- 6. The date when the bank transfer has been made (in accordance with the deadlines mentioned on the Conference's website) will be considered as the date of participant's registration. Should one deadline be missed, the price of the next applicable fee will be charged automatically.

§5. Cancellation terms and fees refund

- 1. All Conference participation cancellations have to be sent by e-mail to the Organizer: eurobiotech@targi.krakow.pl. The date when the e-mail resignation was sent is binding.
- 2. Administrative fee for processing the conference registration related to cancellation is 350 PLN.
- 3. In the case of a withdrawal submitted by 30 April 2026, the payment made will be refunded in full, minus the administrative fee of 350 PLN for processing the conference registration. Refunds will be processed after the conclusion of the Conference.
- 4. For cancellation received after 30 April 2026 no refund will be provided.
- 5. No-shows without prior cancellation: payment will not be refunded.
- 6. Participants have the right to delegate another person to participate in the Conference on their behalf at no additional charge. The application should be sent by e-mail to eurobiotech@targi.krakow.pl within 10 working days before the Conference.

§6. Participant's duties and responsibilities

- 1. All participants are required to wear their ID badge in a visible location during the Conference and all accompanying events and show their ID badge on request to the Conference personnel.
- 2. All Participant's conference materials for Oral Presentations, Sessions etc. should be made in accordance with the Organizer's guidelines and instructions. The Organizers is not responsible for materials which are not compliant with the requirements.
- 3. During the Conference Participant is obliged to comply with fire and safety regulations at the Conference venue and to follow the Organizer's and Conference Organizer instructions.
- 4. Participants have full material liability for damage done by them both on the premises of the facilities where any conference activities are conducted.
- 5. The Organizers and the Conference Organizer is not responsible for Participants' belongings which may be lost, damaged or stolen during the Conference.

§7. Personal data protection and consent to their processing

- 1. Personal data will be processed in order to perform the contract the subject of which is participation in the Conference, in order to register participation in the Conference pursuant to art. 6 sec. 1it. b GDPR, on the basis of a contract concluded by accepting the Regulations.
- 2. Personal data will be used in accordance with the Act of May 10, 2018 on the protection of personal data (Journal of Laws of 2018, item 1000) and the Regulation of the European Parliament and the EU Council 2016/679 of April 27, 2016. on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (Journal of Laws UE L. 119 of 04/05/2016).
- 3. The personal data administrator: Targi w Krakowie Ltd. with headquarters at Galicyjska 9 street, 31-586 Kraków, entered in the Register of Entrepreneurs No. KRS 0000192313, kept by the District Court for Kraków-Śródmieście, XI Commercial Division. NIP: 676-10-50-090, REGON: 350952838.
- 4. The data administrator will process the personal data of the Participants for the purpose of implementing the contract concluded in connection with participation in the Conference, as well as for the purpose of marketing their own products and services in a traditional form and for other purposes for which the Participant has consented, such as sending commercial information by electronic marketing, direct marketing by phone, marketing of products and services cooperating with the Administrator or resulting from the Participant's instructions or the agreement between the Organizers, the Conference Organizer and the Participant (in particular, consideration of applications, complaints).
- 5. The Administrators may entrust the personal data of Participants to other entities (subcontractors or business partners) for processing, in accordance with the principles set out in the Regulation of the European Parliament and the EU Council 2016/679 of 27 April 2016 on the protection of individuals with regard to data processing personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (Journal of Laws UE L 119), the Administrators keeps a register of persons authorised to process personal data.
- 6. Providing their personal data by Participants is always voluntary. However, failure to provide data marked as necessary makes it impossible to conclude an agreement related to the application for participation in the Conference.

- 7. Participants has the right to: access their data and rectify it, delete it (unless further processing is necessary to comply with legal obligations or to establish, investigate or defend claims), limit its processing, transfer such data, object to its processing.
- 8. Consent may be withdrawn at any time. Withdrawal of the consent does not affect the legality of the processing carried out prior to its withdrawal. The withdrawal of consent to the processing of personal data may be sent by e-mail to the following address: iod@targi.krakow.pl

- 10. For the purposes of organizing and supporting Participants' involvement in the Conference, the Organizer may enable access to a dedicated Conference Application. Participants who decide to use the Application acknowledge that their personal data (name, surname, e-mail address) may be transferred to the technological provider of the Application (Gridaly sp. z o.o.) solely for the purpose of creating and servicing the Participant's account, pursuant to art. 6 sec. 1 lit. b GDPR.
- 11. Use of the Application is entirely optional. However, in order to access and use the Application, the Participant shall be obliged to read and accept the terms of use and privacy policy of the Application available at: https://www.gridaly.com/pl/terms-and-conditions.

§8. Consent to record and use the image

- 1. Participants agree to the free use of their image recorded in the Conference materials, films, presentations, as well as during the Conference and in the Conference Organizer's promotional and information materials.
- 2. Copying the materials of the Conference and / or recording the Conference, as well as making such materials and recordings available to third parties, is illegal and is subject to the criminal liability described in the Act on Copyright and Related Rights (Journal of Laws of February 4, 1994, No. 24, item 84, as amended).
- 3. The participants declare that they have proprietary copyrights or the necessary licenses to the published materials. Participants declare that the publication of materials and their content is in accordance with the law and does not infringe the rights or goods of third parties.
- 4. In the event that third parties raise justified claims against the Participants resulting from the violation of the rights referred to in paragraph above, by publishing the materials provided, the Party providing the contested materials undertakes to satisfy claims and pay royalties or damages that the Organizers would have to bear, together with all costs incurred for breaches.

- 5. By participating in the Conference the Participant grants the Organizer an unlimited, non-exclusive, unlimited territorially, quantitatively and qualitatively license with the right to grant a sub-license of the same scope as the license to use the materials and the abstract in whole or in part, independently as part of a collective work, in combination with works and elements freely selected by the Organizer, as well as its studies, adaptations and all the created materials, graphics, fragments, shots, documentation for information, documentation and educational purposes of the Event itself, including in particular its use, sharing on the Internet, Intranet, as well as part of any telecommunications services with the use of any systems and devices on the Platform and on other Organizer's websites.
- 6. The license referred to in sec. 5 above (hereinafter referred to as the "License"), is granted to the Organizers upon presenting during oral presentation in terms of the materials and upon sending the abstract in terms of the abstract and includes the use of the materials and the abstract in the following fields of use:
 - a. recording and reproducing the materials and the abstract using magnetic recording technique and digital technology (including DVD, magneto-optical carriers);
 - b. in the scope of disseminating the materials and the abstract public performance, display, playback and broadcasting, as well as public sharing of the materials and the abstract on the Internet, including the platform using all available techniques, including using the Internet, Intranet and other computer networks, broadcasting the materials and the abstract via multimedia and ICT networks;
 - c. modifying the materials and the abstract in whole or in part and developing it in whole or in part, including, inter alia, the right to correct, modify and change the entire materials and the abstract or its individual elements.
- 7. The license also includes the Organizer's right to exercise dependent rights to the materials and the abstract in all the fields of use referred to in sec. 5 and 6 above; including in particular the right to make changes to the materials and the abstract and prepare it and use it.

§9. Final provisions

- 1. The Organizers reserves the right to make changes in the Conference program. The current program is published on the website: https://eurobiotech.krakow.pl/
- 2. If the Conference is not held for reasons caused by "force majeure", the Participant is not entitled to compensation or reimbursement of any fees related to participation in the Conference. Force majeure is considered to be e.g. epidemics, strikes, riots, fire, flooding and weather phenomena such as lightning, hurricane, flood, hail, rain, as well as obligations under sanitary or epidemiological

regulations, conclusion of agreements on their basis preventing or limiting the organization of the Conference, or the introduction of other regulations according to which the organization of the Conference will not be possible.

- 3. To all matters not settled herein, provisions of the Polish Civil Code shall apply.
- 4. Any disputes that may arise from participation in the Conference shall be settled by Polish courts on the grounds of the Polish procedure.
